No.LESI-SS-FE-0011-2014 3725 /LESI, Bhubaneswar, dated the 07.05.2022

On the recommendation of the Odisha Public Service Commission, Cuttack vide their Letter No.3425 dated 12.04.2022, fifty five (55) number of candidates are hereby appointed as Insurance Medical Officers, Group-A (Junior Branch) of Odisha ESI Medical Service Cadre under Labour & ESI Department and posted in the places as mentioned against each in the scale of pay of Rs.56,100/- (Level-12, Cell-1 of the Pay Matrix) as per the ORSP Rules, 2017 and other allowances as admissible and sanctioned by Government from time to time.

- 1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
- 2. The appointments are subject to their medical fitness to be determined by the Medical Board and their character and antecedents are found to be satisfactory after verification. In case, adverse reports are received, the services of the candidates concerned would be terminated forthwith.
- 3. The appointees should join their respective place of posting within 20 (twenty days) from the date of issue of this Notification failing which their appointment shall automatically be cancelled. No joining time/ extension of joining time will be allowed.
- 4. No T.A / D.A will be allowed to join the place of posting.
- 5. The newly appointed Insurance Medical Officers are required to undergo Initiation Programme as would be decided by Government.
- 6. The IMOs who are continuing their PG study or any higher study or working as Senior Resident / Tutor / JR and in case, they are selected for regular appointment on the recommendation of the OPSC may be allowed to join at the places of their posting and relieved by the concerned Superintendent and IMO Incharge on the next day in order to enable them to continue their PG study or any

higher study or their Senior Residentship / Tutorship / JRship in respective Medical Colleges on submission of an undertaking to join and serve under the State Government at the places of posting on completion of their PG study/ higher study/ Senior Residentship/ Tutorship/ JRship.
