Sub: Filing of nomination for selection of eminent Trade Union Leaders to be honoured on 1st May, 2023.

Sir,

Inviting a reference to the above cited subject, I am to say that the Government in Labour & ESI Department, Odisha desire to honour eminent Trade Union Leaders on 1st May (Shramik Divas) for their valuable contribution to the trade union movement. The details of the scheme are as below:-

Objective:-

The objective is to recognize valuable contributions made by the Trade Union Leaders for trade union movement and rendering service to the workers/labourers as well as assisting the Government directly or indirectly in providing relief social security and other welfare measures to the workers.

Scope:-

The honour will be presented to five Trade Union Leaders working in Odisha with outstanding contribution in trade union field at least for the past ten years or more on 1st May each year by the Government in Labour & ESI Department, Odisha.

Nomination:-

- (a) The Trade Union leaders associated with the Trade Union activities in the State of Odisha for at least ten years are to be nominated for the purpose.
- (b) All the national level Trade Unions and Federations will be requested to file the nomination in the prescribed form for the purpose to the Under Secretary to the Government, Labour & ESI Department, Odisha. The nominations will be scrutinized with reference to the guidelines and eligibility.



Guidelines and Eligibility:-

- (a) The honour will be given to the 5 Trade Union leaders who have distinguished record of work in Trade Union field, more specifically outstanding contribution towards rendering service to the workers / labourers as well as in assisting the Government machineries directly or indirectly for providing relief, social security benefits and other welfare measures to the workers/labourers.
- (b) The following eligibility criteria are required to be fulfilled:
- The nominated Trade Unions Leader should be continuously associated with any registered Trade Union / Federation in the State of Odisha at least for the past ten years.
 - He/She should have distinguished record of service in the trade union field.
 - He/She should have outstanding contributions towards providing relief / assistance to the workers / labourers either directly or through the union to which he is associated with.

You are, therefore, requested to file nomination in the form enclosed for the aforesaid purpose to the Under Secretary to Government, Labour & ESI Department, Odisha within five days of issue of this letter for taking further necessary action in the matter. The biodata of the sponsored person may also be enclosed with the filled-in application form.
