CORRIGENDUM

In the aftermath of pre bid consultation on dt:14-12-2023the RFP No-19142 Date: 08-12-2023 of I&PR Department stands modified to the extent of the following:

- 1. Point No. 4 ELIGIBILITY CRITERIA: The first point may be read as: "The bidder must have been a registered company under the Indian Companies Act or registered individual/partnership firm or Proprietorship firm/unit and must have at least three years' experience in visual outdoor advertisement. The applicants availing exemption of EMD as MSE registered need to furnish required certificate of registration with DIC / OSIC /NSIC as the case may be".
- Point No. 5- Evaluation & Selection Procedure: Parameters for Technical evaluation & Scoring.

Parameter at sl-3, in Colum -01 may be read as "Experience in the field of Digital Wall Painting in Govt. Organization/Dept./Ministry/PSU/Reputed private organization".

3. Point No.8 - EMD:

May be read as: "Bid Security (E.M.D.): The tender document shall accompany with an Earnest Money Deposit (EMD) of Rs.20,000/- without which the tender shall be rejected. The Earnest Money Deposit should be in favour of DDO, Information and Public Relations Department Government of Odisha, Bhubaneswar in the form of DD/FDR/Banker's Cheque / NSC / Postal Savings Pass Book in an envelope along with the sealed covers of "Technical" bid. The EMD may be forfeited (a) if they withdraw or modify their bids/ violate the Terms and Conditions of the Tender documents during the period of validity and shall be suspended for the period of 3 years from participating in any Government/ PSU Tenders.(b) in case of a successful bidder, if the bidder fails to sign the contract in accordance with this tender document. 4. Point No. 9-PERFORMANCE SECURITY:

Department", within 7 days of notifying the acceptance of proposal for the award of contract as per the format at Annexure-E, the performance security shall be valid for a period of three months beyond the entire contract period (i.e. Performance Security) must be valid from the date of effectiveness of the contract to a (period of 3 months beyond the contract period) as its commitment to perform services under the contract. Failure to comply with the above requirements shall constitute sufficient grounds for the forfeiture of the EMD.
