On the recommendation of the Odisha Public Service Commission, Cuttack vide their Letter No.6275 dated 04.08.2023 and in continuation to this Department Notification No.8529/LESI, Dated 11.09.2023, the following one (01) number of candidate is hereby appointed as Insurance Medical Officer, Group-A (Junior Branch) of Odisha ESI Medical Service Cadre under the Labour & ESI Department and posted in the place as per choice mentioned against in the scale of pay of Rs.56,100/- (Level-12, Cell-1 of the Pay Matrix) under the ORSP Rules, 2017 and other allowances as admissible and sanctioned by Government from time to time.

- 2. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
- 3. The appointment is subject to medical fitness to be determined by the Medical Board and character and antecedents are found to be satisfactory after verification. In case, adverse reports are received, the service of the candidate concerned would be terminated forthwith.
- 4. The appointee should join the place of posting within 20 (twenty) days from the date of issue of this Notification. The IMO, who is already serving in another Department of the Government of Odisha is permitted to join after handing over the present charges.
- 5. No T.A / D.A will be allowed to join at the place of posting. On joining, he shall be governed by the Odisha ESI Medical Service (Method of Recruitment and Conditions of Service) Rules, 2014, and other rules and regulations applicable to the cadre of Insurance Medical Officers under the Labour & ESI Department as on date and from time to time
- 6. The newly appointed Insurance Medical Officer is required to undergo Orientation Programme as would be decided by Government.

- 7. The inter-se seniority of these appointed officers shall be in the same order as in the above mentioned OPSC Letter No.6275 dated 04.08.2023.
- 8. The IMO who is continuing higher study or working as Senior Resident / Tutor / JR shall be relieved by the concerned Superintendent/ IMO In-charge on the next day of joining in order to enable him to continue the higher study. The IMO will submit an undertaking to the extent that, he will join and serve under the ESI Scheme, Government of Odisha on completion of his higher study. Further, the IMO shall intimate regarding joining in the respective institution of higher study to the Labour & ESI Department/ Director of ESI Scheme, Odisha.
