The cost of Earnest money deposit / Bid security of the amount specified for the work in Col. 06, above the bidder shall Make electronic payment using his / her **Internet Banking enabled** account with designated Bank or their aggregator Bank such as **SBI / ICICI / HDFC** or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks. Bidders desirous to hire machineries or equipments from out side the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as bid security.

4. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
5. Bids shall be received only **“On-line”** on or before **16:00 P.M. of 03.02.2026.**
6. Bids received “on-line” shall be opened **at 11:30 A.M. on 04.02.2026** in the office of the **Superintending Engineer, Sambalpur (R&B) Division No.I, Sambalpur, Odisha** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The cost of bid documents as mentioned in Column. 7 the bidders shall make electronic payment using his / her internet banking enabled account with designated Ban or their aggregator Bans such as SBI / ICICI / HDFC or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks.
- 8. Rate quoted by the contractor shall be excluding GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice.**

Engineer Contractor desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit in original to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.
